Reporting Instructions: Check your status and reporting instructions at least once a week via the Juror Access Website (<http://jury.idaho.gov>), or the automated jury phone line (846-509-1211). Trial dates/times/instructions can change up to the working day before the trial date, unless the trial was previously cancelled.

Postponements: You may ask for a postponement of jury service but any such postponement granted shall be for the shortest period of time reasonable.
